**WHEREAS**, the country is experiencing an unprecedented health crisis due to the spread and persistence of COVID-19;

Accordingly, the assistance and collaboration of all entities are sought for the immediate resolution of this pandemic;

Ty, to provide the PGI with financial assistance in the amount of Php25,000,000.00 through their Local Government Support Fund – COVID-19 Financial Assistance to Local Government Units allocations which shall be utilized for the acquisition of medical equipment as part of its aim to further enhance its anti-COVID-19 medical programs and services;

**WHEREAS**, the Department of Budget and Management (DBM) issued Local Budget Circular No. 128 which established the *"Guidelines on the Release and Utilization of the Local Government Support Fund – COVID-19 Financial Assistance to Local Government Units in the Bayanihan to Recover as One Act, Republic Act No. 11494"*;

**WHEREAS**, as per Section 3 of Local Budget Circular No. 128 of the DBM, the acquisition of medical equipment is included in the list of programs, projects, and activities permitted to be funded by the Local Government Support Fund – COVID-19 Financial Assistance to Local Government Units in the Bayanihan to Recover as One Act;

**WHEREAS**, this Honorable Body looks forward to DBM's approval to the request of the PGI to LPG Marketers' Association Party List as such will pave the way to the achievement of our goal of further improving the PGI's response and capabilities against COVID-19;

**WHEREFORE**, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –


