WHEREAS, the Philippines is experiencing an unprecedented health crisis due to the spread of COVID-19;

WHEREAS, his Excellency, President Rodrigo R. Duterte, issued Presidential Proclamation No. 1021 which extended the period of the State of Calamity throughout the Philippines due to COVID-19 as declared under Proclamation No. 929;

WHEREAS, the aforesaid Proclamations empowered local government units to appropriate and utilize funds in their efforts to contain the spread of COVID-19;

WHEREAS, the Office of the Provincial Governor sent a Letter to this Honorable Body requesting for the reprogramming of the amount of Thirty Million Three Hundred Thousand Pesos (Php30,300,000.00) from the Local Disaster Risk Reduction and Management Fund (LDRMF) from various accounts therein to the account "Various Programs Projects and Activities for COVID-19";

WHEREAS, this Honorable Body has determined that the request is timely, crucial, and appropriate considering that the reprogramming of such amounts will strengthen the capability and capacity of the Provincial Government of Isabela to contain the spread of COVID-19;






