WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to ensure and support among other things, the promotion of health and safety of Isabeleños;

A RESOLUTION AUTHORIZING THE CONSTRUCTION OF HEMODIALYSIS CENTER BUILDING IN MANUEL A. ROXAS DISTRICT HOSPITAL IN ROXAS, ISABELA

WHEREAS, to cater the growing needs of patients who need to undergo dialysis treatments, the PGI aims to open additional four (4) Dialysis Centers which will be located in the four (4) District Hospitals which are owned, managed and operated by the PGI, to wit; Milagros T. Albano District Hospital, Manuel A. Roxas District Hospital, Cauayan District Hospital, and Echague District Hospital. The said four (4) Hemodialysis Centers to be opened will likewise be owned, managed and operated by the PGI;

**WHEREAS**, this year, the PGI will be constructing a Hemodialysis Center Building in Roxas, Isabela, specifically located in Manuel A. Roxas District Hospital;

WHEREAS, pursuant to Administrative Order No. 2016-0042, there is a need to secure Permit To Construct (PTC) from the Department of Health before the construction of a Hemodialysis Building to ensure compliance with the guidelines in planning and design of health facilities;

WHEREAS, this August Body deems it necessary to authorize the construction of the Hemodialysis Center Building in Manuel A. Roxas District Hospital in line with the thrust of the PGI to provide affordable hemodialysis procedures to indigent patients in the province;

WHEREAS, in compliance to the requirements of the Department of Health for the issuance of Permit to Construct Hemodialysis Center Building, upon motion of the HON. EMMANUEL JOSELITO B. AÑES, duly seconded and approved by all the members present in a session duly assembled, it was —
