**WHEREAS**, the Department of Health (DOH) issued Administrative Order No. 2015-0021 which requires physicians who recently finished residency training program in DOH Teaching and Training Hospital to serve in government hospitals in priority unreserved areas;

**WHEREAS**, Dr. Emy Ann C. Sumawang-Rivera, a physician covered by the above DOH Administrative Order, is desirous to provide the Province of Isabela with medical assistance by extending her medical expertise to the patients of Echague District Hospital;

**WHEREAS**, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREAS**, after careful review of the terms and agreements of the Memorandum of Agreement, this Honorable Body deems it beneficial and advantageous to the Province to grant the Provincial Governor the necessary authority;
