**WHEREAS**, in pursuit of the United Nations' Sustainable Development Goals and in furtherance of its mandate to promote the welfare of its people, the Provincial Government of Isabela is committed in ending poverty-related hunger incidence in the Province of Isabela, and is dedicated to attain lasting food-sufficiency and improved nutrition for Isabeleños;

**WHEREAS**, in line with this commitment, the Provincial Government of Isabela adopts policies that promotes the consistent growth of its local agricultural industry, and implements sustainable initiatives that provide nourishment to its people;

**WHEREAS**, the National Government has formulated Ambisyon Natin 2040, a twenty-five-year long vision designed to serve as a foundation for the development planning of sitting administrations. It envisions significantly reduced hunger-incidence and poverty rates in the country by year 2040;

**WHEREAS**, a whole-of-nation approach is necessary to achieve the visions of Ambisyon Natin 2040. Recognizing this, the Partnership against Hunger and Poverty, or PAHP, composed of the DSWD, DA, and DAR, has engaged local government units, non-government organizations, the private sector, and stakeholders – an engagement called the Enhanced Partnership Against Hunger and Poverty (EPAHP) – for the implementation of government programs and extension of government services that aims to mitigate hunger, ensure food and nutrition security, and reduce poverty in urban and rural communities, including marginalized communities, in the local setting;

**WHEREAS**, the Provincial Government of Isabela has expressed its dedication to take part and contribute to the National Government’s cause to achieve the visions of Ambisyon Natin 2040 and the goals of the PAHP;

**WHEREAS**, submitted before this Honorable Body, for its review and approval, is a Memorandum of Understanding to be entered into by various government agencies, the Provincial Government of Isabela, the Confederation of Irrigators Association in MARIIS, Inc. and three Private Farming Education Institutions in the Province of Isabela, namely: Jicas Agri-Integrated Farm and Learning Site; Rami’s Farm; and FDN Integrated Farm for the implementation and extension of EPAHP-related programs and services to the people of Isabela;

**WHEREAS**, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREAS**, after careful review of the terms and agreements of the Memorandum of Understanding, this Honorable Body deems it to be just and lawful, advantageous to the Province, and consistent with the mandate of the PGI to promote the welfare of Isabeleños;

**WHEREFORE**, premises considered, upon motion of Honorable Abegail V. Sable, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. 
