WHEREAS, the Provincial Government of Isabela recognizes the crucial role of the labor sector in providing the people with access to goods and services and in bringing progress and prosperity to the Province;

WHEREAS, in its pursuit to provide the labor sector with genuine, meaningful, and established representation in its governance processes, the Provincial Government of Isabela has appropriated funds for the creation and operation of the Labor Sector Representative position in the Sangguniang Panlalawigan;

WHEREAS, this Supplemental Budget is a clear and conclusive manifestation of the resolve of the Provincial Government of Isabela to provide the labor sector with representation in the Sangguniang Panlalawigan and shall serve as the funding source for its creation and operation for the remaining period of the year 2022;

WHEREFORE, the immediate passage of this ordinance is earnestly sought.

Section 1. The Supplemental Budget No. 02 of the Provincial Government of Isabela for Fiscal Year 2022, as herein provided, covering the amount of **One Million Six Hundred Forty Six Thousand Eight Hundred Eighty Four Pesos (Php1,646,884.00)** is hereby approved and authorized.

Section 2. Source of Funds. The funds provided in this Supplemental Budget shall be sourced from the Savings of the Provincial Government of Isabela for Fiscal Year 2022 as certified by the Provincial Treasurer and the Provincial Accountant as follows:

Section 5. Effectivity. This Ordinance shall take effect immediately upon approval.






