AN ORDINANCE REPROGRAMMING THE AMOUNT OF FIFTEEN MILLION PESOS (PHP15,000,000.00) FROM FOUR ACCOUNTS IN THE 20% ECONOMIC DEVELOPMENT FUND OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR FISCAL YEAR 2022 TO AN ACCOUNT WITHIN THE SAME APPROPRIATION TITLED "CONSTRUCTION OF BACNOR BRIDGE PHASE III LOCATED AT BACNOR EAST-BACNOR WEST, BURGOS, ISABELA"

WHEREAS, the Provincial Governor, the Honorable Rodolfo T. Albano III, sent a letter to this August Body requesting that the amount of Fifteen Million Pesos from four (4) accounts within the 20% Economic Development Fund of the Provincial Government of Isabela for Fiscal Year 2022 be reprogrammed to finance the construction of the Bacnor Bridge Phase III in Burgos, Isabela;

WHEREAS, such a letter was tossed to the Committee on Finance and Appropriations to determine the lawfulness and appropriateness of such a request;

WHEREAS, the 10th Sangguniang Panlalawigan enacted Ordinance No. 2021-49-01 and passed Resolution No. 2021-23-05 which approved and authorized the Annual Budget and the Annual Investment Plan of the Provincial Government of Isabela for Fiscal Year 2022, respectively, which includes all the Programs, Plans, and Activities (PPAs) chargeable to its 20% Economic Development Fund;

WHEREAS, through such legislative measures, the Provincial Governor was empowered to augment or reprogram any item in the 20% Economic Development Fund of the Provincial Government of Isabela for Fiscal Year 2022 from savings in other items within the same appropriation provided that the basis for such augmentation or reprogramming will ensure that the resources and development plans of the Provincial Government of Isabela will align with current development issues and that its 2022 Annual Investment Plan will be implemented effectively;

WHEREAS, after careful review, the Committee on Finance and Appropriations determined that the aforesaid request of the Provincial Governor for funding of the Bacnor Bridge in Burgos, Isabela which will be sourced from four (4) accounts in the 20% EDF of the PGI for FY 2022 will spur progress in Burgos, Isabela and improve social and economic conditions therein to the benefit of the entire Province of Isabela;

WHEREFORE, the passage of this Ordinance is earnestly sought.
