WHEREAS, presented for the approval of this August Body is a letter from the Provincial Governor, the Honorable Rodolfo T. Albano III, requesting the reprogramming for the change of expense class and object of expenditures of the account "2 Units Static Kermentle Rope 6mm 100m", with funds appropriated thereto amounting to Two Hundred Thousand Pesos (Php200,000.00), from Capital Outlay/OPPE to "MOOE/Other Supplies Expense";

WHEREAS, the Provincial Government of Isabela adopts and implements a disaster risk reduction and management approach aimed at building the resilience of communities to disasters and providing timely and responsive services to the people;

WHEREAS, in line with its strategies and approach to raising the resilience of its communities to disasters, the Provincial Government of Isabela endeavors to utilize the funds appropriated for the acquisition of static kermentle ropes within the current fiscal year;

WHEREAS, to ensure the achievement of such an endeavor, there is a need to change the expense class of the account "2 Units Static Kermentle Rope 6mm 100m" and reprogram the amounts appropriated thereto from Capital Outlay to MOOE;

WHEREAS, considering that effecting such a change within the LDRRM Fund advances the disaster preparedness, management, and response capabilities of the Province, this August Body hereby approves the aforesaid request of the Provincial Governor;

WHEREFORE, the immediate enactment of this Ordinance is earnestly sought.


Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.
