WHEREAS, the Tulong Panghanapbuhay sa ating Displaced / Disadvantaged (TUPAD) Workers Program of the Department of Labor and Employment (DOLE) was first implemented by the Provincial Government of Isabela on November 19, 2019 and continued to be implemented on the succeeding years;

WHEREAS, the Program was successful in providing assistance to displaced workers and helping them cope up with the closure or slowing down of operations of their employers as a result of economic disruptions and/or occurrence of natural disasters, calamities, or armed conflicts that affect their economic base, and in augmenting the meager income of the underemployed and seasonal workers;

WHEREAS, due to the TUPAD Workers Program's accomplishments, the Department of Labor and Employment-Region 2 proposed for its reimplementation to enable the displaced workers, underemployed and seasonal workers to engage in short-term community works to provide them with temporary wage employment;

WHEREAS, the PGI recognizes the benefits of ensuring the proper implementation and monitoring of the TUPAD Workers Program. As such, the PGI is desirous to reenter into an Agreement with DOLE RO2 for the reimplementation of the TUPAD workers program;

WHEREAS, presented for the consideration of this Honorable Body is a proposed Memorandum of Agreement between the Provincial Government of Isabela and Department of Labor and Employment-Region 2 relative to the implementation of the Fourth TUPAD Program in the Province of Isabela;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body deems the Agreement to be beneficial and advantageous to the Province. Hence, the Provincial Governor must be granted with the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT IS HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
