**A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH, ECHAGUE DISTRICT HOSPITAL, SOUTHERN ISABELA MEDICAL CENTER AND DR. KIMBERLY JEANE ROSARIO-LAZARO, FOR THE POST-RESIDENCY DEPLOYMENT PROGRAM**

**WHEREAS**, Republic Act No. 11223, otherwise known as the “*Universal Health Care Act of 2019*”, provides that the Department of Health (DOH) shall deploy health care workforce under the National Health Workforce System to augment human resource needs in public health systems;

**WHEREAS**, the Department of Health (DOH) is also mandated under Executive Order No. 102, to provide assistance to local government units in effectively implementing programs, projects, and services for the provision of health care services to every Filipino;

**WHEREAS**, to further improve the medical and health care capabilities of the Provincial Government of Isabela (PGI) and to ensure the availability of skilled health professionals who can deliver quality health care services in prioritizing poor and underserved areas, it is enjoined by law to provide basic health care services to its constituents thru the deployment of additional work force;

**WHEREAS**, since the PGI is in dire need of a Medical Officer (MO) III / IV who will provide specialty health care to augment the medical human resource requirement in the Province, the DOH shall deploy PRDP Physicians who recently finished the residency training program in DOH Teaching and Training Hospital as human resource complement in government hospitals in priority underserved areas;

**WHEREAS**, pursuant to the requirements of Administrative Order No. 2015-0021 and the mandates set forth in its Post-Residency Deployment Program, the DOH aspires to deploy a PRDP Physician in Echague District Hospital, in the person of Dr. Kimberly Jeane Rosario-Lazaro of Southern Isabela Medical Center, to augment the medical human resource requirement in the Province;

**WHEREAS**, the implementation of the Post-Residency Deployment Program and the deployment of physicians to hospitals operated by the Provincial Government of Isabela necessitates the execution of a Memorandum of Agreement;

**WHEREAS**, Section 465, (b) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

**WHEREAS**, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREAS**, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
