WHEREAS, the Sangguniang Panlalawigan observes a time-honored tradition in which it accords due recognition to individuals who brought prestige to the name of the Province of Isabela or have significantly advanced the welfare of its people;

WHEREAS, Senator JV provides significant support to the programs and projects of JCI including the JCI Cauayan Bamboo, a local chapter of JCI stationed in Cauayan City, Isabela, which regularly conducts philanthropic activities in various communities in Cauayan City such as providing textbooks to students, food and other goods to disaster-stricken areas, and the empowerment of underrepresented sectors of society, among others;

WHEREAS, this Honorable Body commends the resolve of Senator JV to serve the country and the people, and reveres his unshakeable will in pushing for the attainment of his noble and invaluable advocacies – traits that earned him a victory in the 2022 National Elections and another term in the Senate;


WHEREFORE, upon motion of Honorable Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –


