A RESOLUTION EXPRESSING THE PROFOUND GRATITUDE OF THE PROVINCIAL GOVERNMENT OF ISABELA TO ATTY. SILVESTRE H. BELLO III FOR HIS GREAT EFFORTS TO ADVANCE THE WELFARE OF ISABELEÑOS

WHEREAS, the Sangguniang Panlalawigan observes a time-honored tradition in which it accords due recognition to individuals who brought prestige to the name of the Province of Isabela or have significantly advanced the welfare of its people;

WHEREAS, Atty. Silvestre H. Bello, who hails from the Cagayan Valley Region, is a seasoned lawyer and a staunch human rights advocate who has an extensive, decorated, and distinguished career in public service;

WHEREAS, Atty. Silvestre H. Bello, fondly referred to as "Bebot", is presently the Secretary of the Department of Labor and Employment (DOLE);

WHEREAS, such enhanced access to DOLE-implemented programs was pivotal to the Provincial Government of Isabela's successful management and containment of COVID-19 as such helped curb the pandemic's socio-economic effects on the people, especially on those who were displaced from their work and whose micro, small, and medium businesses closed, through the extension of timely and much-needed financial relief;

WHEREAS, Atty. Bello was also exceptionally active in implementing the Government Internship Program (GIP) in the Province of Isabela which helped raise productivity in the local government sector and provided employment opportunities to the Isabeleño youth;

WHEREAS, this Honorable Body is forever grateful to Atty. Bello for his unending support to the Provincial Government of Isabela and his genuine concern for the Isabeleños;

WHEREFORE, upon motion of the Honorable Faustino G. Dy III, duly approved and seconded in a session duly assembled, it was –
