**WHEREAS**, Republic Act No. 7307, otherwise known as "*An Act Creating the Philippine Carabao Center to propagate and promote the Philippine Carabao and for other purposes*", was enacted to conserve, propagate, and promote the Philippine Carabao as a source of draft animal power, meat, milk and hide;

**WHEREAS**, the Provincial Government of Isabela accords preferential consideration to the development of its agriculture sector into a reliable and sustainable source of nutrition, livelihood, and income for its people. Accordingly, it actively formulates new programs and supports existing projects aimed at enhancing the productivity of local farms and local farmers;

**WHEREAS**, the Provincial Government of Isabela recognizes the value of undertaking cooperative and collaborative engagements with individuals, groups, and agencies which have expertise in a particular subject or endeavor deemed promotive of the general welfare of its people;

**WHEREAS**, the Provincial Government of Isabela (PGI), the Philippine Carabao Center (PCC), and the San Pablo Isabela Farmers' Dairy Cooperative (SPIFDC) have signified their collective aspiration to work together to develop Isabela's carabao industry;

**WHEREAS**, the three organizations endeavor to jointly implement the **Accelerating the Livelihood and Build-Up Assets (ALAB) Project**. This project calls for the coordination of the said organizations in which, briefly, the PCC shall provide technical and financial support to the Provincial Government of Isabela. Meanwhile, the PGI shall provide project monitoring services and the necessary space for the construction of facilities and placement of equipment while the SPIFDC shall be tasked to disperse the project yields to their members and submit reports on the status of the project;

**WHEREAS**, for the ALAB Project to be legally implemented, a Memorandum of Agreement between the PGI, PCC, and the SPIFDC for such purpose must be executed;

**WHEREAS**, presented for the consideration of this Honorable Body is the proposed Memorandum of Agreement between the PGI, PCC, and the SPIFDC concerning the implementation of the ALAB Project;

**WHEREAS**, after careful review, this Honorable Body deems the said MOA to be just, lawful, in line with the agriculture and poverty alleviation policies of the Provincial Government of Isabela, and promotive of the welfare of its people;

**WHEREAS**, Section 465(b)(vi) of the Local Government Code empowers the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

**WHEREAS**, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREAS**, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was -
