A RESOLUTION RESTATING THE “NO OBJECTION” STAND OF THE SANGGUNIANG PANLALAWIGAN ON THE PROPOSED INSTALLATION OF DAEBO GREEN PACIFIC INCORPORATED OF AN EIGHTEEN (18) MEGAWATT SOLAR POWER PLANT IN THE MUNICIPALITY OF LUNA, ISABELA

WHEREAS, it is the policy of the State, as declared in Republic Act No. 9153 or the “Renewable Energy Act of 2008”, to accelerate the exploration and development of renewable energy sources and to encourage the utilization thereof to effectively prevent or reduce harmful emissions and balance the goals of economic growth with the protection of health and the environment;

WHEREAS, the Provincial Government of Isabela is firmly committed to extending all appropriate and necessary support for the exploration, development, and utilization of sustainable and green renewable energy sources in the Province of Isabela;

WHEREAS, such commitment was manifested in the 9th Sangguniang Panlalawigan’s declaration of “no objection” to the proposed construction by Daebo Green Pacific Incorporated of an 18-megawatt solar power plant in the Municipality of Luna Isabela, made through Resolution No. 266, series of 2017;

WHEREAS, submitted for the review of this Honorable Body is a Letter from the Provincial Governor, the Honorable Rodolfo T. Albano III, requesting that the Sangguniang Panlalawigan issue a resolution showing that the Province of Isabela still supports the aforesaid solar power plant project in Luna, Isabela;

WHEREAS, after careful review of the letter-request of the Provincial Governor including all of its documentary attachments and guided by the aforesaid commitment of the Provincial Government of Isabela, this August Body deems it appropriate to reaffirm the favorable stand of the Provincial Government of Isabela on the construction of the aforesaid solar power plant project;

WHEREAS, this stand or declaration of the Sangguniang Panlalawigan is subject to Daebo Green Pacific Incorporated's compliance with pertinent environmental, labor, and construction laws, rules, and regulations;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION RESTATING THE "NO OBJECTION" STAND OF THE SANGGUNIANG PANLALAWIGAN ON THE PROPOSED INSTALLATION OF DAEBO GREEN PACIFIC INCORPORATED OF AN EIGHTEEN (18) MEGAWATT SOLAR POWER PLANT IN THE MUNICIPALITY OF LUNA, ISABELA
