WHEREAS, in line with its health-related policies, the Provincial Government of Isabela endeavors to improve its coordination and communication lines regarding its acceptance of patients needing obstetric and pediatric care and other appropriate medical care referred by Gamu Rural Health Unit and Medical Center;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the Provincial Government of Isabela and Gamu Rural Health Unit and Medical Center that seeks to establish a patient referral system for patients needing obstetric and pediatric care and other appropriate medical care between the two institutions;

WHEREAS, after careful perusal, this August Body determined the submitted draft Memorandum of Agreement between the Provincial Government of Isabela and Rural Health Unit and Medical Center to be just, lawful, and promotive of the welfare of Isabeleños;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
