ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE AGRICULTURAL TRAINING INSTITUTE – REGIONAL TRAINING CENTER 02, DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE NO. 02, TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY – CAGAYAN PROVINCIAL OFFICE, TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY – ISABELA PROVINCIAL OFFICE, THE PROVINCIAL LOCAL GOVERNMENT UNIT OF CAGAYAN, VARIOUS MUNICIPAL LOCAL GOVERNMENT UNITS OF THE PROVINCES OF ISABELA AND CAGAYAN FOR THE IMPLEMENTATION OF THE “SCHOOL-ON-AIR ON ORGANIC AGRICULTURE PRODUCTION PROGRAM”

WHEREAS, Section 5 of Republic Act No. 10068 or the Organic Agriculture Act of 2010 mandated the creation of the National Organic Agriculture Program the purpose of which is the establishment of “a comprehensive organic agricultural program through the promotion and commercialization of organic farming practices, cultivation, and adoption of production and processing methods”;

WHEREAS, the Department of Agriculture is the government agency tasked to implement national agricultural policies, programs, and projects, including the National Organic Agriculture Program;

WHEREAS, the Agricultural Training Institute is the capacity-building arm of the Department of Agriculture the mandate of which is to extend training, farm and business advisory, demonstration, information, education, and communication services to local government units and other clientele;

WHEREAS, the Department of Agriculture, through the Agricultural Training Institute – Regional Training Center 02, has recognized the School-on-Air, a specially designed radio-based distance learning program, as an effective modality in the extension of education and training and has utilized the same in providing effective education to learners especially to those living in rural areas;

WHEREAS, the Agriculture Training Institute – Regional Training Center 02 endeavors to facilitate the extension of Organic Agriculture Production (OAP) education and training, with NC II Assessment, to their learners in the Provinces of Cagayan and Isabela by establishing a partnership agreement with the Technical Education And Skills Development Authority – Cagayan Provincial Office (TESDA – Cagayan), Technical Education And Skills Development Authority – Isabela Provincial Office (TESDA – Isabela), the Provincial Local Government Unit of Cagayan (PLGU Cagayan), the Provincial Government of Isabela (PGI), and various Municipal Local Government Units of the Provinces of Isabela and Cagayan;

WHEREAS, the Provincial Governor, the Honorable Rodolfo T. Albano III, has signified his intention to enter into such an agreement with the mentioned government agencies and has requested this August Body to grant him the necessary authority to represent the Provincial Government of Isabela in the signing of a Memorandum of Agreement for the extension of organic agriculture training to Isabeleño farmers through the School-on-Air modality;

WHEREAS, submitted for the consideration and approval of this August Body is the proposed Memorandum of Agreement among the mentioned government agencies involving the extension of organic agriculture training to farmers in Region 02 through the School-on-Air modality;

WHEREAS, after careful review, this August Body determines the proposed Memorandum of Agreement to be just and lawful and that granting the Provincial Governor the necessary authority to sign the same on behalf of the Provincial Government of Isabela is beneficial to Isabeleños and promotive of their welfare, and furthers the local policies on the advancement of local farmers and the local agriculture;
