**A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A PARTNERSHIP AGREEMENT WITH ASIA SOCIETY FOR SOCIAL IMPROVEMENT AND SUSTAINABLE TRANSFORMATION, INC. FOR THE IMPLEMENTATION OF THE LATTER'S "PROJECT SIBOL" IN THE PROVINCE OF ISABELA**

**WHEREAS**, the Provincial Government of Isabela upholds a policy in which it accords preferential consideration to the welfare of its farmers in the formulation of its policies and implementation of its programs;

**WHEREAS**, Asia Society for Social Improvement and Sustainable Transformation, Inc. (ASSIST), a non-stock and non-profit organization duly organized and existing under the Philippine laws, implements project SIBOL. Under such a project, ASSIST trains corn growers on regenerative soil methods and good agricultural practices which aim to improve agricultural productivity, yield, and soil health management;

**WHEREAS**, ASSIST endeavors to implement project SIBOL in the City of Ilagan, Isabela;

**WHEREAS**, recognizing the benefits of project SIBOL, the Provincial Governor, the Honorable Rodolfo T. Albano III, came to favorable terms with ASSIST for the implementation of such a project in the Province of Isabela;

**WHEREAS**, submitted for the review and consideration of this August Body is the proposed Partnership Agreement between the Provincial Government of Isabela and ASSIST for the implementation of project SIBOL in the Province of Isabela, and a letter from the Provincial Governor stating his request that he be granted with authority to sign the said Partnership Agreement on behalf of the Provincial Government of Isabela;

**WHEREAS**, after careful review of the proposed Partnership Agreement, this August Body finds the same to be just and lawful and that granting the Provincial Governor the necessary authority to sign such a document on behalf of the Provincial Government of Isabela is beneficial to Isabeleños and promotive of their welfare, and is in line with local policies for the advancement of local farmers and the local agriculture sector;

**WHEREAS**, Section 465(b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
