WHEREAS, Section 5(i) of Executive Order No. 124, dated 30th of January 1987, authorized the Department of Public Works and Highways (DPWH) to classify roads and highways into national, provincial, city, and barangay roads;

WHEREAS, to set the criteria and guidelines for the evaluation of roads for conversion from local to national and vice versa, the DWPH issued Department Order No. 133, series of 2018;

A RESOLUTION INTERPOSING NO OBJECTION AND EXPRESSING CONCURRENCE TO THE CONVERSION OF THE ILAGAN-DIVILACAN ROAD, DELFIN ALBANO – STO. TOMAS – CABAGAN ROAD, TUMAUINI – DELFIN ALBANO ROAD, ILAGAN – QUIRINO – ROXAS ROAD, AND ILAGAN – GAMU ROAD FROM THEIR PRESENT CLASSIFICATION AS PROVINCIAL ROADS INTO NATIONAL ROADS THEREBY REQUESTING FOR SUCH PURPOSE THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO DECLARE SUCH ROADS AS NATIONAL ROADS

WHEREAS, to ensure that the quality and dimension of local roads in the Province of Isabela are in line with national standards, to promote the harmonious connectivity of local road systems, and to enhance the accessibility of remote and coastal areas in the Province, among other grounds, the Provincial Government of Isabela has requested the DPWH to declare the following local roads as National Roads, viz:

Ilagan-Divilacan Road;
Delfin Albano–Sto. Tomas-Cabagan Road;
Tumauini-Delfin Albano Road;
Ilagan–Quirino-Roxas Road; and
Ilagan-Gamu Road

WHEREAS, recognizing that the conversion of the above-listed local roads into national roads will improve the connectivity of local road networks and that such will bring socio-economic development in the remote and far-flung areas of the Province, this August Body interposes no objection and expresses its concurrence to such an endeavor;

WHEREAS, this August Body extends its dutiful request to DPWH Secretary Manuel M. Bonoan that this endeavor of the Provincial Government of Isabela be favorably considered;

WHEREFORE, upon motion of the Honorable Manuel Faustino U. Dy, duly approved and seconded in a session duly assembled, it was –


RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION INTERPOSING NO OBJECTION AND EXPRESSING CONCURRENCE TO THE CONVERSION OF THE ILAGAN-DIVILACAN ROAD, DELFIN ALBANO – STO.
