WHEREAS, after careful review, this August Body finds that Executive Order No. 14, Series of 2022, of the Office of the Provincial Governor to be just, lawful, and in line with local policies on the attainment of the highest standards of personnel recruitment and development in the Provincial Government of Isabela;
