**WHEREAS**, Republic Act No. 11201 created the Department of Human Settlements and Urban Development (DHSUD) which is empowered to formulate and prescribe land use planning guidelines and zoning standards and regulations for the guidance of cities and municipalities in the formulation of their respective Comprehensive Land Use Plans (CLUPs) and Zoning Ordinances (ZOs);

**WHEREAS**, the DHSUD issued Memorandum Circular No. 2021-005 providing for the revised review and approval processes of CLUPs and ZOs of Highly Urbanized Cities, Independent Component Cities, Component Cities and Municipalities, and Metro Manila Cities and Municipalities;

**WHEREAS**, in compliance with such a circular, the Municipality of Quirino, Isabela submitted their CLUP to DHSUD Region 02 to determine the completeness of the required documents and was thereafter referred to the Provincial Land Use Committee (PLUC) of the Province of Isabela for further review and assessment;

**WHEREAS**, the Technical Working Group (TWG) of the PLUC conducted evaluations of the CLUP and Zonification of LGU Quirino, Isabela. Based on the findings of the PLUC TWG, the PLUC issued Resolution No. 02, Series of 2022, finding the CLUP of LGU Quirino, Isabela to be in accordance with the guidelines and policy standards set by the DHSUD. Moreover, the requirement for the mainstreaming of disaster risk reduction and climate change adaptation has also been approved and found to be in conformity with the Provincial Development and Physical Framework Plan;

**WHEREAS**, Section 468 (a)(2)(vii) of the Local Government Code empowers the Sangguniang Panlalawigan to review the Comprehensive Land Use Plans and Zoning Ordinances of component cities and municipalities under its authority;

**WHEREAS**, after careful review of the CLUP and Zoning Ordinance of LGU Quirino, Isabela, this August Body determined that the same is just, lawful, in line with the development plans and strategies of their local government and the provincial government, and conforms with the standards set by the DHSUD;

**WHEREFORE**, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –


