**A RESOLUTION RECOGNIZING OUTREACH PHILIPPINES, INCORPORATED AS A RECOGNIZED CIVIL SOCIETY ORGANIZATION IN THE PROVINCE OF ISABELA**

---

**WHEREAS**, the Provincial Government of Isabela is committed to upholding its policy on ensuring transparency in its government processes through, among others, strengthening citizen participation and involvement in its policy-formulation and decision-making mechanisms;

**WHEREAS**, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-83 which established the *Guidelines on the Accreditation of Civil Society Organizations (CSO) and Selection of Representatives to the Local Special Bodies*, including the procedure and requirements for the recognition of organizations as a CSO;

**WHEREAS**, in line with the aforesaid DILG Memorandum, the Sangguniang Panlalawigan (SPI) published a Call for Accreditation encouraging organizations operating within the Province of Isabela to apply for accreditation or recognition as a Civil Society Organization (CSO), and to apply for reaccreditation for those that were previously accredited;

**WHEREAS**, the Outreach Philippines, Incorporated, through its Chief Executive Director, Mme. Krizzia Ria Y. Velasquez, signified its intention to be granted the status as a Civil Society Organization in the Province of Isabela;

**WHEREAS**, the SPI Committee on Awards, Citations, and Accreditations, which has the jurisdiction to evaluate the application of organizations for accreditation or recognition as a CSO in the Province of Isabela, conducted a committee hearing to assess the qualification of Outreach Philippines, Incorporated based on criteria set forth by the SPI and the aforesaid DILG Memorandum;

**WHEREAS**, the SPI Committee on Awards, Citations, and Accreditations determined that the Outreach Philippines, Incorporated satisfactorily complied with the criteria and requirements established by the SPI and the DILG for the granting of status as a CSO in the Province of Isabela, and made a recommendation to this August Body based on such findings;

**WHEREAS**, this August Body adopts and concurs with the finding of the SPI Committee on Awards, Citations, and Accreditations;

**WHEREFORE**, upon motion of the Honorable Lourdes S. Panganiban, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION RECOGNIZING OUTREACH PHILIPPINES, INCORPORATED AS A RECOGNIZED CIVIL SOCIETY ORGANIZATION IN THE PROVINCE OF ISABELA**

**RESOLVED FURTHER**, that the recognition granted herein shall be effective until June 30, 2025, subject to revocation based on grounds set forth by pertinent laws, rules, regulations, and SPI legislative issuances.
