WHEREAS, Republic Act No. 10354 otherwise known as the “*Responsible Parenthood and Reproductive Health (RPRH) Act of 2012*”, provides that the State shall promote and protect the rights and social welfare of its people especially the youth, mothers, and the unborn, and instill health consciousness among them;

WHEREAS, the Office of the President issued Executive Order No. 141 Series of 2021 which declared that the rising cases of teenage pregnancy must be immediately addressed and for such purpose, has recognized it as a national priority;

WHEREAS, the Commission on Population (POPCOM) is the lead government agency directed to continue to educate leaders, parents, and other community members about evidence-based strategies to reduce, if not eliminate, adolescent pregnancy, and improve adolescent reproductive health;

WHEREAS, the POPCOM and the Provincial Government of Isabela share a mutual objective in safeguarding the physical, moral, spiritual, social well-being, and intellectual of the youth and encouraging them to participate in public and civil affairs;

WHEREAS, the POPCOM, through its Region 02 Office, and the Provincial Government of Isabela aspires to work together in addressing teenage pregnancy in the Province of Isabela through the conduct of an Adolescent Health And Development (AHD) Program to conceptualize, develop, and produce the Social Behavior Change Communication (SBCC) materials for adolescents, parents, men and women, local leaders and individuals that will carry key messages on adolescent's health, responsible sexuality and male involvement in responsible parenthood and family planning;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela providing their respective duties and functions on the implementation of the AHD Program and the conduct of training on Gender Responsive Population Strategies in the Province of Isabela;

WHEREAS, after a careful review, this Honorable Body deems the aforesaid Memorandum of Agreement to be just, lawful, and promotive of the welfare of the Isabeleños;

WHEREAS, under Section 465 (b)(1)(vi) of the Local Government Code of 1991, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of Honorable Lourdes S. Panganiban, duly approved and seconded in a session duly assembled, it was –


