A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 20-051-B, SERIES OF 2020 OF THE SANGGUNIANG BAYAN OF ROXAS, ISABELA AS INTRA VIRES

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 20-051-B, series of 2020 enacted by the Sangguniang Bayan of Roxas, Isabela titled “**An Ordinance Reclassifying a Total of Three Hundred Seventy-Three and Fifty (372.50) Square Meters More or Less of Residential Land Owned by Talavera Meganorth Holdings Corp., Covered Under TCT No. T-376088 with Lot No. 2825-B (7825-B), Situated in Barangay Rizal, Municipality of Roxas, Isabela to Commercial Land**”;

WHEREAS, as provided in the Ordinance, the Sangguniang Bayan of Roxas, Isabela changed the classification of the aforementioned lot from Residential land to Commercial land;

WHEREAS, Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, grants the Local Government Units the power to reclassify lands to residential, commercial, industrial, or other purposes subject to the determination that such land will have more economic value if reclassified;

WHEREAS, this Honorable Body recognizes that local government units are more abreast with regard to the needs of their citizens and the conditions within their jurisdiction and thus have the necessary competence in formulating the appropriate strategies and implementing the essential measures for the advancement of their people and territory;

WHEREAS, after careful review, subject to pertinent regulations and issuances of the Housing and Land Use Regulatory Board and other relevant laws and rules, this Honorable Body finds that the reclassification of the aforementioned lot from Residential land to Commercial land made pursuant to Ordinance No. 20-051-B, series of 2020 of the Sangguniang Bayan of Roxas, Isabela to be a valid exercise of their legislative power and is within the authority of the Municipal Local Government Unit of Roxas, Isabela as prescribed by law;

WHEREFORE, upon motion of Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –


RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 20-051-B, SERIES OF 2020 OF THE SANGGUNIANG BAYAN OF ROXAS, ISABELA AS INTRA VIRES.
