ALBANO III, TO ENTER INTO TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR THE IMPLEMENTATION AND MANAGEMENT OF THE ANNUAL OPERATION PLAN FOR FISCAL YEAR 2022

WHEREAS, the Local Government Code of 1991, and as reiterated in Executive Order No. 138, series of 2021, mandated that the responsibility of delivering basic health services and facilities to the people be devolved to Local Government Units (LGUs);

WHEREAS, in compliance with the mandate of the UHC Act and to facilitate the process of devolving to LGUs the responsibility of delivering basic health services and facilities to the people, the DOH commits to extending necessary and appropriate assistance to LGUs to improve the functionality and effectiveness of province-wide and city-wide health systems;

WHEREAS, the Provincial Government of Isabela (PGI) made and reaffirmed its commitment to implement the UHC Act in the Province of Isabela through the institutionalization of the Province-wide health system in the Province of Isabela and the adoption of the Local Investment Plan for Health (LIPH);

WHEREAS, the LIPH establishes the partnership between the PGI and the DOH in carrying out their respective mandates as provided in the UHC Act and as committed by the PGI in its institutionalization of the province-wide health system in the Province of Isabela;

WHEREAS, the PGI and the DOH partnered in formulating the plans and strategies for the proper and effective implementation of the LIPH;

WHEREAS, as a display of their steadfast commitment to implementing the plans, programs, and activities (PPAs) as established in the LIPH and the 2022 Annual Operation Plan (AOP), the PGI and the DOH endeavor to enter into a Terms of Partnership providing their respective duties and responsibilities in the implementation and execution of the PPAs in the LIPH and 2022 AOP

WHEREAS, submitted for the review and approval of this August Body is the proposed Terms of Partnership between the PGI and the DOH providing their respective duties and responsibilities in implementing the LIPH and 2022 AOP;

WHEREAS, under Section 465(b)(vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Terms of Partnership on behalf of the Provincial Government of Isabela;
