3. Reiterating our review action on your 2021 Annual Budget that the grant of **Cash Gift** in the amount of Three Million Four Hundred Thirty Thousand Pesos (P3,430,000.00) under the Mayor's Office shall be in accordance with DBM Budget Circular No. 2016-4 dated April 28, 2016, on the Updated Rules and Regulations on the Grant of the Year-end Bonus and Cash Gift for FY 2016 and Years Thereafter;
4. The following Plantilla positions shall be converted to generic class titles in accordance with Local Budget Circular No. 137 dated July 13, 2021, on the Index of Occupational Services, position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition, to wit:

5. The position of **Assistant City Health Officer** with SG-23/5 at the City Health Office is not within the list of position titles found in DBM LBC No. 61 dated March 18, 1996 the revised Index of Occupational Services, position titles and salary grades (IOS) in the Local Government. ***However, when the position becomes vacant, it is hereby recommended to be abolished or to be downgraded to a position applicable for a 10 bed capacity hospital and to the equivalent income classification of the city;***
  
6. The Positions of **Medical Officer IV** with SG-23/3 and **Dentist IV** with SG-23/5 is not in accordance with Section 4(d) Local Budget Circular No. 53, which states that:

*“The highest level of Positions below the Assistant Department Head shall be limited to the allocated Salary Grade for component cities which is Salary Grade 22”*

***However, when the positions becomes vacant, it is hereby recommended to be abolished or to be downgraded to a position applicable for a 10 bed capacity hospital and to the equivalent income classification of the city.***

7. This is to reiterate our review action on your 2021 Annual Budget that the Position of **Driver II SG-4** with Item Nos. **14.21, 14.22 & 14.23** under the **City General Services Office** shall *not be allowed* pursuant to the Qualification Standard (Revised 1997) of the Civil Service Commission and the Manual on Position Classification and Compensation Scheme in LGUs. Item 9.2.1.6 under Chapter 9 of the Manual on Position Classification and Compensation Scheme in LGUs states that the classification of Driver position is dependent on the level/rank of the position they serve. Per established standards, the *allowable level of this position for CGSO is Driver I, SG-3*. Since the subject positions do not conform to the herein prescribed allowable SG allocation, corrections shall be effected without diminution in salary of the concerned personnel. However, subsequent salary increase shall be applied only on the correct classified position;

The utilization of 5% LDRRMF shall be in accordance with the approved Local Disaster Risk Reduction and Management Plan pursuant to RA 10121 and its implementing Rules and Regulations, as supplemented by NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations as supplemented by Local Budget Memorandum No. 82 dated June 14, 2021 copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRM. **However, the Proposed New Appropriations by Object of Expenditures on the LEP is not consistent with the LDRRM plan (Annex E-2);**

Further, the acquisition of Motor Vehicles shall be subject to the provisions of Budget Circular No. 2019-3 dated May 16, 2019 and Administrative Order No. 14 dated December 10, 2019;

**RESOLVED FURTHER**, to require the City of Cauayan, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.


**RESOLVED FURTHERMORE**, to furnish the City of Cauayan, Isabela that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.


