WHEREAS, presented before this August Body is a letter from the Provincial Governor, the Honorable Rodolfo T. Albano III, expressing his request to be granted the necessary authority to sign a Memorandum of Agreement with the Jose R. Reyes Memorial Medical Center on behalf of the PGI;

WHEREAS, under such an agreement, the Jose R. Reyes Memorial Medical Center will accept an employee of the PGI in the person of Dr. Ampy T. Vinarao, Medical Officer III in the Provincial Health Office — Field Health Services, who will undergo a Fellowship Training and Continuing Medical Education under the former's Department of Nephrology for a period of two years. In turn, Dr. Vinarao will utilize the knowledge and education gained in the said training in rendering service to the PGI;

WHEREAS, after careful review of such an agreement, this August Body determined that the same is just and lawful, will benefit the Isabeleños, and advances the PGI policy on providing quality, affordable, and accessible medical and healthcare services to the people;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;
