EXPLANATORY NOTE

WHEREAS, Section 2, par. I of the Philippine Reduction and Management Act of 2010 (R.A. 10121) declares that it is the policy of the State to recognize and strengthen the capacities of LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

A RESOLUTION APPROVING AND ADOPTING THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 02-2022, SERIES OF 2022, TITLED "A RESOLUTION APPROVING THE 2023 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN IN THE AMOUNT OF TWO HUNDRED THIRTY FOUR MILLION SIX HUNDRED TWENTY THOUSAND NINE HUNDRED TWO PESOS (P234,620,902.00)"

WHEREAS, as provided under R.A. 10121, not less than five percent (5%) of the estimated revenue from regular sources shall be set aside as the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk management activities;

WHEREAS, the LDRRMF shall cover the thirty percent (30%) lump-sum allocation for Quick Response Fund (QRF) and the seventy percent (70%) allocation for disaster prevention and mitigation, preparedness, response, rehabilitation, and recovery;

WHEREAS, the Provincial Disaster Risk Reduction and Management Council (PDRRMC) submitted before this August Body, for its approval and consideration, PDRRMC Resolution No. 02-2022, Series of 2022, which endorsed and approved the LDRRMF Investment Plan of the Provincial Government of Isabela for Fiscal Year 2023. Such an Investment Plan is attached hereto and shall become an integral part of this Resolution.

WHEREAS, as stated in the said Resolution, the Provincial Government of Isabela (PGI) aspires to appropriate **TWO HUNDRED THIRTY FOUR MILLION SIX HUNDRED TWENTY THOUSAND NINE HUNDRED TWO PESOS (P234,620,902.00)** to the FY 2023 LDRRMF Investment Plan which represents the five percent (5%) of the estimated revenue of the PGI from regular sources;

WHEREAS, after a careful review of the proposed budget allocation and the proposed programs, projects, and activities (PPAs) appearing therein, this August Body finds the aforesaid PDRRMC Resolution to be in line with the provisions of the R. A. No. 10121 and its Implementing Rules and Regulations, consistent with the Local Risk Reduction and Management policies of the Provincial Government of Isabela, and advances the welfare of the Isabeleños;

WHEREAS, this Honorable Body hereby manifests its approval to the proposed CY 2023 Local Disaster Risk Reduction and Management Fund Investment Plan of the Province of Isabela and the amounts provided for the implementation of the PPAs stated therein;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION APPROVING AND ADOPTING THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 02-2022, SERIES OF 2022, TITLED "A RESOLUTION APPROVING THE 2023 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN IN THE AMOUNT OF TWO HUNDRED THIRTY FOUR MILLION SIX HUNDRED TWENTY THOUSAND NINE HUNDRED TWO PESOS (P234,620,902.00)"


