WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to provide quality, affordable, and accessible medical and healthcare services to the people;

WHEREAS, in line with such a policy, the PGI commits to exploring all possible lawful means to improve its medical and healthcare services, including the establishment of partnership agreements with private institutions that will provide education and training to PGI personnel;

WHEREAS, presented before this August Body is a letter from the Provincial Governor, the Honorable Rodolfo T. Albano III, expressing his request to be granted with an authority to sign a Memorandum of Agreement, on behalf of the PGI, with the Southern Isabela Medical Center and Dr. Dorries B. Batang Lopez, Medical Officer III in the Palanan Station Office;

WHEREAS, under such an agreement, the Southern Isabela Medical Center will accept an employee of the PGI in the person Dr. Dorries B. Batang-Lopez who will enroll and undergo its Practice-Based Residency Training in Family and Community Medicine;

WHEREAS, after careful review of such an agreement, this August Body determined that the same is just and lawful, will benefit the Isabeleños, and advances the PGI policy on providing quality, affordable, and accessible medical and healthcare services to the people;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
