This ordinance underscores the provincial government's proactive approach to personnel management and its continuous efforts to promote efficiency, effectiveness, and transparency in governance. By allocating resources judiciously and responsibly, the Provincial Government of Isabela endeavors to foster a conducive work environment that nurtures innovation, professionalism, and excellence among its workforce and reaffirms its commitment to ensuring the welfare of its personnel.

In view of the foregoing, the immediate passage of this ordinance is earnestly sought.
