EXPLANATORY NOTE

The Sangguniang Panlalawigan of Isabela, recognizing the paramount importance of aligning the resources and development plans of the Provincial Government of Isabela with current development imperatives, has duly enacted ordinances approving and authorizing the Annual Budget of the Province. Under these ordinances, the Governor has been empowered to augment or reprogram allocations within the 20% Economic Development Fund to ensure optimal utilization and responsiveness to prevailing socio-economic challenges.

AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF UNEXPENDED BALANCES FROM SIX (6) ACCOUNTS UNDER THE 20% ECONOMIC DEVELOPMENT FUND - CONTINUING OF THE PROVINCIAL GOVERNMENT OF ISABELA AMOUNTING TO TWO HUNDRED EIGHT MILLION TWENTY FIVE THOUSAND SEVEN HUNDRED NINETY THREE PESOS (PHP208,025,793.00) TO THE PROGRAM/PROJECT/ACTIVITY "LIVELIHOOD ASSISTANCE"

In consonance with the authority vested upon him by the Sangguniang Panlalawigan, the Governor seeks to address the emergent needs of the Isabeleños by reprogramming unexpended balances from six (6) accounts within the 20% Economic Development Fund, as detailed in this ordinance. Specifically, the Governor proposes the reprogramming of Php208,025,793.00 to the Program/Project/Activity "Livelihood Assistance".

The urgency of this reprogramming initiative stems from the imperative to effectively address the pressing needs of the Isabeleños, especially those adversely affected by the El Niño Phenomenon. By redirecting these funds to the Livelihood Assistance program, the Provincial Government of Isabela will be better equipped to provide timely and targeted assistance to individuals facing crisis situations, thereby mitigating the impact of socio-economic challenges on vulnerable sectors of our society.

This strategic reallocation of resources not only fulfills the mandate of the Provincial Government of Isabela but also demonstrates our unwavering commitment to prioritize the welfare and well-being of our fellow Isabeleños.

In light of the foregoing, the immediate approval of this ordinance is earnestly sought.

Section 1. Coverage. This Ordinance shall cover the items, accounts, and appropriations provided in Section 2 hereof.

Section 2. Reprogramming of Funds. That the unexpended balances from the below provided accounts under the 20% Economic Development Fund – Continuing of the Provincial Government of Isabela are hereby reprogrammed as follows:

Section 3. Utilization of Funds. The disbursement and utilization of funds made pursuant to this Ordinance shall adhere to existing government budgeting, accounting, and auditing laws, rules, and regulations.

Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed funds to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.
