AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF THE AMOUNT OF ONE HUNDRED THIRTY SEVEN MILLION TWO HUNDRED FIFTY THOUSAND SIXTY TWO AND 31/100 PESOS (PHP137,250,062.31) FROM THE 70% PMPRRR PORTION OF THE SPECIAL TRUST FUND OF UNEXPENDED LDRRM FUND IN 2019, 2020, 2021, 2022, AND 2023 OF THE PROVINCIAL GOVERNMENT OF ISABELA TO THE PROJECT/PROGRAM/ACTIVITY "LIVELIHOOD DEVELOPMENT PROGRAM"

Recognizing the vulnerability of the province to natural disasters, the Provincial Government of Isabela has adopted and implemented a comprehensive disaster risk reduction and management strategy aimed at fortifying community resilience and delivering prompt, effective assistance to its people.

AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF THE AMOUNT OF ONE HUNDRED THIRTY SEVEN MILLION TWO HUNDRED FIFTY THOUSAND SIXTY TWO AND 31/100 PESOS (PHP137,250,062.31) FROM THE 70% PMPRRR PORTION OF THE SPECIAL TRUST FUND OF UNEXPENDED LDRRM FUND IN 2019, 2020, 2021, 2022, AND 2023 OF THE PROVINCIAL GOVERNMENT OF ISABELA TO THE PROJECT/PROGRAM/ACTIVITY "LIVELIHOOD DEVELOPMENT PROGRAM"

This esteemed Body, cognizant of the severe repercussions of the ongoing El Niño Phenomenon on the province's agricultural sector, has issued Resolution No. 2024-14-06, declaring a State of Calamity across the entirety of the province. This decision was informed by an exhaustive assessment conducted by the Office of the Provincial Agriculturist, supported by recommendations from the Isabela Provincial Disaster Risk Reduction and Management Council.

The assessment has revealed staggering damages amounting to Php1,487,405,308.23, with recent forecasts from PAG-ASA indicating the persistence of drought conditions until September 2024. In response to this crisis, the Provincial Disaster Risk Reduction and Management Council convened on May 02, 2024, and issued Resolution No. 03-2024, authorizing the reprogramming of Php137,250,062.31 from the 70% PMPRRR portion of the Special Trust Fund of Unexpended LDRRM Fund of the Provincial Government of Isabela for the years 2019, 2020, 2021, 2022, and 2023 to finance a livelihood development program for disaster victims.

Supplementary to the PDRRM Council resolution is a revised Local Disaster Risk Reduction and Management Fund Investment Plan, duly endorsed by the Governor, reflecting the proposed reallocation of funds to the Program/Project/Activity "Livelihood Development Program," as approved by this August Body pursuant to Section 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-01.

Considering that the proposed ordinance seeks to implement a livelihood development program designed to mitigate the current hardships faced by El Niño victims, facilitate their economic recovery, adheres to the stipulations outlined in the joint memorandum circular, and complies with pertinent budgeting and accounting regulations, its immediate approval is earnestly sought.

Section 1. Coverage. This Ordinance shall cover the items, accounts, and appropriations provided in Section 2 hereof.

Section 2. Reprogramming of Funds. That the unexpended balances from the below provided accounts under the Local Disaster Risk Reduction and Management Fund – Special Trust Fund are hereby reprogrammed as follows:

Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed funds to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.






