EXPLANATORY NOTE

This proposed ordinance aims to reprogram the remaining funds from several previously authorized programs under the Provincial Government of Isabela's (PGI) 20% Development Fund, directing them toward the Repair/Improvement of Queen Isabella Park and the Procurement of Palay and Rice Subsidy Program.

The 20% Development Fund is allocated to projects that drive socio-economic progress across Isabela. Over the years, certain projects have achieved their objectives with unutilized balances, presenting an opportunity to address current priorities. The reallocation of these savings aligns with the Governor's budgetary authority, as approved in the Annual Budgets, allowing for strategic adjustments to ensure funds are responsive to evolving community needs.

The reallocated funds will serve two critical purposes. First, the Repair/Improvement of Queen Isabella Park will promote local heritage, enhance its appeal as a tourism destination, and ensure a safe recreational space for tourists and residents alike. Second, the Procurement of Palay and Rice Subsidy Program will address immediate needs in the agricultural sector, stabilizing rice prices, supporting local farmers, and bolstering food security measures for the province.

Through this ordinance, the PGI demonstrates a commitment to using public resources responsibly, maximizing their impact to meet both infrastructure and food security needs. This ordinance is not only fiscally responsible but ensures that Isabela's public funds directly benefit and strengthen local communities, reinforcing the provincial government's dedication to sustainable and timely development.

Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed funds to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.
