AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF FUNDS IN THE AMOUNT OF FIFTEEN MILLION SIX HUNDRED FORTY ONE THOUSAND ONE HUNDRED NINETY NINE AND 92/100 PESOS (P15,641,199.92) SOURCED FROM FOUR (4) PROGRAMS FOR CATTLE AND LARGE ANIMAL PROCUREMENT TO THE "PROCUREMENT OF (US) BEEF CATTLE"

This proposed ordinance seeks approval for the reprogramming of funds amounting to Fifteen Million Six Hundred Forty-One Thousand One Hundred Ninety-Nine and 92/100 Pesos (P15,641,199.92), allocated to four cattle and large animal procurement programs. The reprogrammed funds will be directed to the "Procurement of (US) Beef Cattle" to address emerging priorities in the Province of Isabela's agricultural sector.

The Provincial Government of Isabela (PGI) has identified the need to bolster its livestock resources by procuring high-quality US beef cattle. This procurement aims to improve the quality and productivity of local cattle, contribute to food security, and support the agricultural livelihood of Isabela's farmers. The proposed reallocation of funds is in line with the authority granted to the Governor in prior appropriation ordinances, permitting the reprogramming of savings and unutilized balances to better respond to the current needs and priorities of the province.

Redirecting these funds to procure US beef cattle allows the Provincial Government to maximize the impact of its resources in a way that supports both the agricultural economy and food security goals, ensuring a sustainable investment in Isabela's livestock industry. This reprogramming is a fiscally responsible measure that aligns with PGI's commitment to responsive and strategic resource management, directly benefiting the local community and strengthening the provincial livestock sector.

Furthermore, with the holiday season approaching, there is an anticipated increase in demand for meat products. By procuring US beef cattle, the province can better prepare to meet this seasonal surge in meat consumption, ensuring that local markets are well-supplied and that the agricultural sector can capitalize on the increased demand.

This strategic reallocation of funds not only addresses immediate needs but also positions the province to effectively respond to market demands during peak consumption periods, thereby supporting both producers and consumers in Isabela.

In line with the foregoing, the approval of this ordinance is earnestly sought.

Section 3. Utilization of Funds. The disbursement and utilization of funds to be made pursuant to this Ordinance shall adhere to existing government budgeting, accounting, and auditing laws, rules, and regulations.

Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed funds to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.
