**A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 24-006 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF ROXAS, ISABELA AS INTRA VIRES**

**WHEREAS**, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sanggunian of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

**WHEREAS**, presented before this Honorable Body is Municipal Ordinance No. 24-006 of the Municipal Local Government Unit of Roxas, Isabela (MLGU Roxas) titled "**AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE LOCAL GOVERNMENT UNIT OF ROXAS, ISABELA IN THE AMOUNT OF TWENTY-EIGHT MILLION (P28,000,000.00) PESOS FROM THE LANDBANK OF THE PHILIPPINES, TO FINANCE THE ACQUISITION OF LANDS TO SERVE AS SITES FOR VARIOUS INFRASTRUCTURE PROJECTS OF THIS LGU**";

**A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 24-006 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF ROXAS, ISABELA AS INTRA VIRES**

**WHEREAS**, as stated in the Ordinance, MLGU Roxas will enter into a Loan Agreement with the Development Bank of the Philippines for the amount of **Twenty-Eight Million Pesos (P28,000,000.00)** to be utilized for the **Acquisition of Land to Serve as Sites for Various Infrastructure Projects**;

**WHEREAS**, section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

**WHEREAS**, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

**WHEREAS**, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to the Ordinance No. 24-006 of the MLGU Roxas, Isabela, this Honorable Body finds that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU Roxas, Isabela as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

**WHEREFORE**, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 24-006 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF ROXAS, ISABELA AS INTRA VIRES.**






