A RESOLUTION EXPRESSING SUPPORT AND NO OBJECTION TO JOINT RESOLUTION NO. 01, SERIES OF 2024 ISSUED BY THE PHILIPPINE NORMAL UNIVERSITY NORTH LUZON, ISABELA STATE UNIVERSITY, AND THE NATIONAL COMMISSION ON INDIGENOUS PEOPLES REQUESTING FOR THE ALLOCATION OF FUNDS IN THE AMOUNT OF THREE MILLION PESOS (Php3,000,000.00) FOR THE THREE-YEAR IMPLEMENTATION OF THE PROPOSED PARATEACHERS' CAPABILITY TRAINING FOR THE AGTA PEOPLE OF PALANAN, ISABELA FROM YEARS 2024 TO 2027, AND FURTHER ENDORSING THE SAID RESOLUTION TO THE OFFICE OF THE GOVERNOR FOR APPROVAL

WHEREAS, the Provincial Government of Isabela is committed to safeguarding, preserving, and enriching the culture and traditions that define the identity of the province, including the ancestral practices observed by its indigenous communities;

WHEREAS, the Philippine Normal University North Luzon (PNUNL), Isabela State University (ISU), and the National Commission on Indigenous Peoples (NCIP) jointly issued a resolution during a Stakeholder's Forum on 28 February 2024, requesting funding in the amount of Php3,000,000.00 for a proposed three-year project, from 2024 to 2027, aimed at empowering the Agta people of Palanan, Isabela to assume the role of educators within their own communities, with the end goal of fostering self-reliance, cultural preservation, and sustainable development among this indigenous group;

WHEREAS, the said resolution, along with the project proposal, was submitted to this August Body for its review and action;

WHEREAS, after careful review and giving due consideration to the Provincial Government of Isabela's long-standing partnership with the PNUNL and ISU in providing high-quality education to the Isabeleños, and with the NCIP in safeguarding, preserving, and enriching the culture and traditions in the province, this August Body finds the resolution and project proposal to be consistent with the education and cultural preservation policies of the provincial government;

WHEREAS, recognizing the significance and potential impact of the proposed project in ensuring a culturally sensitive and inclusive learning environment for the Agta people, this August Body expresses its unequivocal support and offers no opposition to its implementation;

WHEREAS, cognizant of the financial requirements crucial for achieving the stated objectives of the proposed project and ensuring its long-term sustainability, this August Body duly acknowledges the necessity and urgency of securing adequate funding. In light of this, the Body earnestly endorses the project to the esteemed Office of the Governor for further examination and approval.

WHEREFORE, upon motion of Honorable Margarette U. Chin, duly approved and seconded in a session duly assembled, it was -
