ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH — CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT RELATIVE TO THE IMPLEMENTATION OF FINANCIAL GRANTS FOR THE UNIVERSAL HEALTH CARE INTEGRATION SITES

WHEREAS, through the partnership of the Department of Health (DOH) and the PGI, the 2023-2025 Local Investment Plan for Health was enacted, which serves as a vehicle for implementing and consolidating support for health reforms to achieve health sector goals of better health outcomes, a more responsive health system, and equitable healthcare financing through DOH-LGU partnership;

WHEREAS, pursuant to the 2023-2025 Local Investment Plan for Health, the PGI has enacted its AOP 2024 to further advance the goals of the Universal Health Care Act within the province, including the establishment and support of Universal Health Care Integration Sites (UHC-IS);

WHEREAS, recognizing the importance of UHC-IS in delivering comprehensive healthcare services to the community, the PGI seeks to effectively implement the provision of financial grants amounting Three Million Three Hundred Thousand Pesos (P3,300,000.00) to these sites, necessitating a Terms of Partnership with the DOH-CVCHD to ensure seamless coordination and support;

WHEREAS, the said term of Partnership between the PGI and the DOH-CVCHD is necessary to delineate the responsibilities, obligations, and financial commitments of both parties in the provision of healthcare services and the implementation of health sector reforms;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this August Body deems the Terms of Partnership between the PGI with the DOH-CVCHD to be just, lawful, and beneficial to the Province of Isabela, thus, granting the necessary authority to the Governor;

WHEREFORE, upon motion of the Hon. Emmanuel Joselito B. Añes, duly approved in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE RODOLFO T.
