ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT FOR THE IMPLEMENTATION OF HEALTH EMERGENCY BENEFITS AND ALLOWANCES FOR THE ELIGIBLE PUBLIC AND PRIVATE HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS

WHEREAS, Republic Act No. 11712, also known as the Public Health Emergency Benefits and Allowances for Health Care Workers Act, provides for the payment of Health Emergency Allowance (HEA) to eligible public and private HCWs and non-HCWs during the COVID-19 pandemic and future public health emergencies;

WHEREAS, In line with this, there is a need for the PGI and the Department of Health Cagayan Valley Center for Health Development (DOH-CVCHD) to enter into a Memorandum of Agreement (MOA) to delineate the responsibilities, obligations, and financial commitments of both parties in facilitating the grant of HEA to eligible HCWs and non-HCWs in accordance with DOH-DBM JAO No. 2023-0001 and DOH AO No. 2022-0039, and other relevant issuances:

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this August Body deems the Memorandum of Agreement between the PGI with the DOH-CVCHD to be just, lawful, and beneficial to the Province of Isabela;

WHEREFORE, upon motion of the Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT FOR THE IMPLEMENTATION OF HEALTH EMERGENCY BENEFITS AND ALLOWANCES FOR THE ELIGIBLE PUBLIC AND PRIVATE HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS.
