A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-003 (SUPPLEMENTAL BUDGET NO. 02 CY 2023) IN THE AMOUNT OF TWELVE MILLION THREE HUNDRED SIXTEEN THOUSAND NINE HUNDRED FORTY SEVEN PESOS & 78/100 (P12,316,947.78) OF THE MUNICIPALITY OF ECHAGUE, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2023-003, an ordinance approving Supplemental Budget No. 02, Calendar Year 2023, of the Local Government Unit of Echague, Isabela, appropriating the amount of TWELVE MILLION THREE HUNDRED SIXTEEN THOUSAND NINE HUNDRED FORTY SEVEN PESOS & 78/100 (P12,316,947.78) to cover the funding requirements of new and existing regular positions, for the increase in daily rates of all qualified personnel under casual and job order status, and for other purposes of the Municipality of Echague, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of SP Member DELFINITO EMMANUEL L. ALBANO duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2023-003 (2023 Supplemental Budget No. 02) of the Municipality of Echague, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
  - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
  - All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
  - c. The SSL has been fully implemented;
  - d. The general limitations on PS expenditures are not exceeded;
  - e. The classification of the positions is consistent with the standards and implementing rules and regulations of RA No. 6758;
- 2. The utilization of Terminal Leave Benefits in the amount of Seven Hundred Thousand Pesos (P700,000.00) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- 3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.
