A RESOLUTION AUTHORIZING THE WITHDRAWAL OF THE PROVINCE OF ISABELA FROM THE NORTHEASTERN LUZON PACIFIC COASTAL SERVICE INCORPORATED (NLPCSI) AND AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. ALBANO III TO SIGN, ON BEHALF OF THE PROVINCE OF ISABELA, ON MATTERS RELATIVE TO THE CORPORATE WINDING UP AND DISSOLUTION AFFAIRS OF THE NLPCSI

WHEREAS, the NLPCSI was created on January 19, 2004 pursuant to the "Strong Nautical Highway" flagship program of then President Gloria Macapagal Arroyo;

WHEREAS, the NLPCSI seeks to establish a coastal ferry service that will act as an effective bridge to and from the unchartered towns along the coasts of the Provinces of Cagayan, Isabela, Aurora and Quezon that will enhance inter-island farm and sea trade, reduce travel time and transportation costs, create income opportunities/new markets, and promote domestic and international tourism;

A RESOLUTION AUTHORIZING THE WITHDRAWAL OF THE PROVINCE OF ISABELA FROM THE NORTHEASTERN LUZON PACIFIC COASTAL SERVICE INCORPORATED (NLPCSI) AND AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. ALBANO III TO SIGN, ON BEHALF OF THE PROVINCE OF ISABELA, ON MATTERS RELATIVE TO THE CORPORATE WINDING UP AND DISSOLUTION AFFAIRS OF THE NLPCSI

WHEREAS, the NLPCSI was incorporated under the Corporation Code of the Philippines and was registered with the Securities and Exchange Commission as Non-chartered Government Owned and Controlled Corporation (GOCC) which was originally participated by the aforementioned provinces;

WHEREAS, the initial authorized capital stocks of NLPCSI was set to Forty Million Pesos (PhP 40,000,000.00), covered by Four Hundred Thousand (400,000) shares of stock at One Hundred Pesos (PhP 100.00) per share which should be divided equally by the four provinces;

WHERAS, in 2006, the NLPCSI was placed under the management and administration of the Cagayan Economic Zone Authority (CEZA) by paying a subscription amount of Ten Million Pesos (PhP 10,000,000.00), upon the directive of then President Arroyo, in lieu to the withdrawal of membership of the Province of Quezon;

WHEREAS, as of December 31, 2023, or almost Twenty (20) years after its creation the NLPCSI has yet to operationalize its principal business and has neither achieved its purpose and intended objectives nor generated the level of social, physical and economic returns vis-à-vis the resources invested by CEZA and the aforementioned Local Government Units;

WHEREAS, the Chief Executive Officer of CEZA and member of NLPCSI Board of Directors (BOD) signified their intention to Dissolve the NLPCSI due to various operational difficulties encountered; `

WHEREAS, it is in the best interest of the Province of Isabela to withdraw its membership from NLPCSI and to participate in its corporate winding up and dissolution affairs;

WHEREAS, under Section 465, (b) (vi) of R.A. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign, on behalf of the Provincial Government of Isabela, on matters relative to NLPCSI corporate winding up and dissolution;

**WHEREFORE**, upon careful review of the foregoing, and upon motion of the Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVE, TO PASS A RESOLUTION AUTHORIZING THE WITHDRAWAL OF THE PROVINCE OF ISABELA FROM THE NORTHEASTERN LUZON PACIFIC COASTAL SERVICE INCORPORATED (NLPCSI) AND AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T.
