**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-1361 (SUPPLEMENTAL BUDGET NO. 07, FY 2023) IN THE AMOUNT OF FOUR MILLION THREE HUNDRED FORTY THOUSAND FOUR HUNDRED TWENTY THREE PESOS & 23/100 (P4,340,423.23) OF THE MUNICIPALITY OF SAN MARIANO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**

**WHEREAS**, Appropriation Ordinance No. 2023-1361, an ordinance authorizing Supplemental Budget No. 7 for FY 2023 of LGU San Mariano, Isabela the total amount of **FOUR MILLION THREE HUNDRED FORTY THOUSAND FOUR HUNDRED TWENTY THREE PESOS & 23/100 (P4,340,423.23)** from the Share of LGUs from the CY 2020 Collections of Tobacco Excise Tax under RA No. 8240 as amended by RA No. 10351, and as further amended by RA No. 11346 and Savings from the project Concreting of FMR Brgy. Gangalan - Ueg, San Mariano and Road Concreting of Sitio Malaya to Sitio Lapuac, Binatug with Cross Drainage for the allocation of Financial Assistance/Seed Capital to tobacco farmers of the Municipality of San Mariano, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 2023-1361 (Supplemental Budget 07 FY 2023) of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The utilization of the project to be funded from the Local Government share on the Burley and Native Tobacco Excise Tax for the Fiscal Year 2020 amounting to Four Million Two Hundred Ten Thousand Three Hundred Thirty Five Pesos (P4,210,335.00) shall adhere with the provisions of LBM No. 86, dated December 14, 2022 on the Guidelines on the Release and Utilization of the Shares of LGUs from the FY 2020 Collections of Excise Taxes on Locally Manufactured Virginia-type cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, and as Further Amended by RA No. 11346 Chargeable Against the Allocations to Local Government Units (ALGU) under the FY 2022 General Appropriations Act (GAA), Republic Act No. 11639;
2. The utilization of the project to be funded from the savings of Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2019 amounting to One Hundred Thirty Thousand Eighty Eight Pesos & 23/100 (P130,088.23) shall adhere with the provisions of LBM No. 84, dated November 22, 2021 the Guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the FY 2019 collections of Excise Tax on Locally Manufactured Virginia-type Cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs (ALGU) and Unprogrammed Appropriations (UA) under the FY 2021 General Appropriations Act (GAA), Republic Act No. 11518;
3. The proposed projects shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of San Mariano, Isabela to comply with the herein conditions and notify this body of actions taken thereon.
