**WHEREAS**, Appropriation Ordinance No. 2023-1368, an Ordinance authorizing Supplemental Budget No. 8 for CY 2023 of the Municipality of San Mariano, Isabela in the amount of **TEN MILLION EIGHT HUNDRED SEVENTY EIGHT THOUSAND PESOS (P10,878,000.00)** out of the declared savings from the MOOE – Loan Amortization – Various Infrastructure Projects – Interest account for FY 2023 under the Municipal Mayor's Office of the Local Government of San Mariano, Isabela to cover various objects of expenditure for 2023, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2023-1368 (Supplemental Budget No. 8 FY 2023) of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160, and subject further to the following conditions:

1. The appropriation for the grant of Other Personnel Benefits - Service Recognition Incentive (SRI) in the amount of Six Million Sixty Thousand Pesos (P6,060,000.00) shall be in accordance with Administrative Order No. 12 by the President of the Philippines, dated December 7, 2023, Authorizing the Grant of Service Recognition Incentive to Government Employees for Fiscal Year 2023 and DBM Budget Circular No. 2023-2, dated December 13, 2023 on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for FY 2023;
2. The appropriation for the grant of Gratuity Pay to Contract of Service and Job Order Workers in the amount of Five Hundred Seventy Five Thousand Pesos (P575,000.00) shall be in accordance with Administrative Order No. 13 by the President of the Philippines, dated December 7, 2023, Authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for Fiscal Year 2022 and DBM Budget Circular No. 2023-3 dated December 14, 2023, on the Guidelines on the Grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in Government for Fiscal Year 2023;
3. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

**RESOLVED FURTHER**, to require the Municipality of San Mariano, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHER**, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
