Dy Sr. Memorial Hospital to address the need for a steady and sufficient supply of blood;

WHEREAS, the PGI has expressed its firm commitment to actively participate in voluntary blood donation campaigns, thereby supporting efforts to ensure a consistent blood supply for the benefit of patients in need;

WHEREAS, the collaboration between the PGI and St. Mathias Medical Center of Isabela Inc. will enhance the effectiveness and impact of the voluntary blood donation program, with the goal of promoting the well-being and survival of individuals facing medical emergencies;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the PGI and the BFP – Isabela, enumerating their respective duties and responsibilities in the conduct of voluntary blood donation activities;

WHEREAS, after a careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
