WHEREAS, as part of the objectives of the National Government and to support the interventions and programs of the PGI aimed at eradicating malaria and ensuring the sustainability of malaria-free initiatives, the Department of Health - Cagayan Valley Center for Health Development (DOH-CVCHD) vouches to enhance the capacity of the PGI through implementing a financial grant amounting to One Million Pesos (Php 1,000,000.00);

WHEREAS, a Terms of Partnership agreement between the PGI and DOH - CVCHD is necessary to formalize the collaboration and outline specific terms and conditions for the financial grant supporting priority malaria-free sustainability activities within the province;

WHEREAS, the said Terms of Partnership between the PGI and the DOH-CVCHD is necessary to delineate the responsibilities, obligations, and financial commitments of both parties;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this August Body deems the Terms of Partnership between the PGI with the DOH-CVCHD to be just, lawful, and beneficial to the Province of Isabela, thus, granting the necessary authority to the Governor;

WHEREFORE, upon motion of the Hon. Emmanuel Joselito B. Añes, duly approved in a session duly assembled it was –
