WHEREAS, Appropriation Ordinance No. 2023-033, An ordinance authorizing the Annual Budget of the Municipal Government of Jones, Isabela for Fiscal Year 2024 in the amount of THREE HUNDRED FORTY THREE MILLION FIVE HUNDRED TWENTY FIVE THOUSAND PESOS (P343,525,000.00) for the operation of the Municipal Government of Jones, Isabela and THIRTY SIX MILLION EIGHT HUNDRED THOUSAND PESOS (P36,800,000.00) for the operation of its Economic Enterprises and appropriating the necessary funds for the purpose, pursuant to Section 327 of Republic Act 7160, otherwise known as the Local Government Code of 1991.

A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2023-033 (2024 ANNUAL BUDGET) IN THE TOTAL AMOUNT OF THREE HUNDRED EIGHTY MILLION THREE HUNDRED TWENTY FIVE THOUSAND PESOS (P380,325,000.00), OF THE MUNICIPALITY OF JONES, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, the subject Appropriation Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160.

NOW THEREFORE, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare the Appropriation Ordinance No. 2023-033 (2024 Annual Budget) of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

- 1. The implementation of the lump-sum appropriation for SSL VI in the amount of Six Million Nine Hundred Fifty Six Thousand Six Hundred Fifty Two Pesos & 14/100 (P6,956,652.14) shall be deferred pending the release of the guidelines;
- 2. The grant of Clothing Allowance shall be in accordance with DBM Budget Circular No. 2024-1 dated April 4, 2024;
- That the position titles of all positions shall be allocated to their proper titles and salary grades in accordance with the Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition pursuant to Local Budget Circular (LBC) No. 137 dated July 13, 2021;
- Reiterating that the position of Accountant III SG-18 shall be reallocated to Accountant III SG-19 pursuant to DBM Local Budget Circular No. 2009-92 (Annex "B") dated September 3, 2009;
- 5. That all appropriations should be properly classified per specific expense class and object codes in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
- 6. That the utilization of 5% LDRRMF shall be in accordance with the approved Local Disaster Risk Reduction and Management Plan pursuant to RA 10121 and its implementing Rules and Regulations, as supplemented by NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations supplemented by Local Budget Memorandum No. 87 dated June 9, 2023 and finalized by Local Budget Memorandum No. 87-A dated December 28, 2023, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;

7. That the appropriation and utilization of the 20% Development Fund shall be subject to the pertinent provisions of DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;

That the following appropriations under the 20% Development Fund shall be identified or broken-down into specific/project component indicating the *activities/programs* to be undertaken and the *project site/location* in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2007:

- 1. Priority Projects of 42 Barangays for P4,200,000.00
- 2. Construction of Kitchen of the New Multi-Purpose Building for P250,000.00
- 3. Improvement of the Municipal Pasarabo Center for P250,000.00
- 8. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the purchase and specifications of the motor vehicle shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and Budget Circular (BC) No. 2022-1 dated February 11, 2022, and BC No. 2022-1A dated March 1, 2023;
- 9. That the provisions for programs and projects shall be consistent with the approved Annual Investment Program (AIP) of the Municipality prepared in accordance with DILG-NEDA-DBM-DOF JMC No. 1, s. 2016 dated November 18, 2016.

RESOLVED FURTHER, to require the Municipality of Jones, Isabela to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to furnish the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable NHEL C. MONTANO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Jones, Isabela through the **Honorable EVELYN R. RASPADO**, Municipal Mayor.
