**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 026-2023 (SUPPLEMENTAL BUDGET NO. 05 FY 2023) IN THE AMOUNT OF ONE HUNDRED FORTY THREE THOUSAND NINE HUNDRED NINETY TWO PESOS & 85/100 (P143,992.85) OF THE MUNICIPALITY OF DELFIN ALBANO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**

**WHEREAS,** Appropriation Ordinance No. 026-2023, an ordinance authorizing Supplemental Budget No. 5, FY 2023, involving the amount of **ONE HUNDRED FORTY THREE THOUSAND NINE HUNDRED NINETY TWO PESOS & 85/100 (P143,992.85)** from the 20% share in the proceeds from FYs 2018, 2020 and 2021 of Fire Code Fess under RA No. 11639 and RA No. 11936 for the procurement of Supplies and Equipment of the BFP of the Municipality of Delfin Albano, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 026-2023 (Supplemental Budget 05 FY 2023) of the Municipality of Delfin Albano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The utilization of the 20% share in the proceeds collected from FYs 2018 and 2020 of Fire Code Fees chargeable against regular fund FY 2022 GAA under RA 11639 and FYs 2018 and 2021 of Fire Code Fees chargeable against regular fund FY 2023 GAA under RA 11936 amounting to Sixty Nine Thousand Six Hundred Sixty One Pesos & 21/100 (P69,661.21) and Seventy Four Thousand Three Hundred Thirty One Pesos & 64/100 (P74,331.64) respectively, shall adhere with the provisions of DOF-DBM-DILG Joint Circular No. 2015-01, dated February 12, 2015, on the Guidelines on the Release of the Twenty Percent (20%) LGU Share from Fire Code Revenues, as amended by DBM-DILG-DOF Joint Circular No. 1, s. 2023, dated April 17, 2023, the Revised Guidelines on the Release of the Twenty Percent (20%) Shares of Local Government Units (LGUs) in the Fire code Fees;
2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

**RESOLVED FURTHER**, to require the Municipality of Delfin Albano, Isabela to comply with the herein conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to inform the Municipality of Delfin Albano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable ARNOLD EDWARD P. CO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Delfin Albano, Isabela through the **Honorable THOMAS A. PUA, JR.**, Municipal Vice Mayor.


