ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A CONTRACT OF SERVICE WITH THE SCHOOLS DIVISION OFFICE OF ISABELA, TECHNICAL EDUCATION SKILLS DEVELOPMENT AUTHORITY (TESDA) AND TESDA ACCREDITED CENTERS FOR THE IMPLEMENTATION OF THE COMPETENCY ASSESSMENT FOR VOCATIONAL LIVELIHOOD STUDENTS AND INDUSTRY WORKERS

WHEREAS, in compliance with the directives of the State, the Provincial Government of Isabela, thru its Public Employment Service Office (PESO), will implement the Competency Assessment for Technical Vocational Livelihood Students and Industry Workers to ensure competitiveness in the workplace and assist the beneficiaries in their competency assessment, thus, securing their National Certification and be qualified to work competitively;

WHEREAS, TESDA Accredited Centers for this Program consists of 4MF Resources Inc., GENRAM Integrated and Diversified Farm Learning Site Inc., Isabela School of Arts and Trades, Pua Agri-Tourism and Skills Development Center Inc., Roberto Agri-Tourism Ventures and Skills Development Institution Inc., and Southern Isabela School of Arts and Trades;

WHEREAS, under the aforesaid Program, the PGI shall allocate Five Hundred Thousand Pesos (P500,000.00) for the payment of beneficiaries' National Certificates (NC II) while the TESDA Accredited Assessment Centers shall assume the responsibility of assuring that only qualified students and workers shall be included in the list of enrollees;

WHEREAS, for proper implementation and enjoyment of benefits of the Program, it requires the execution of a Contract of Service between TESDA, Schools Division Office of Isabela, and TESDA Accredited Assessment Centers;

WHEREAS, submitted for the review and approval of this August Body is the draft Contract of Service to be executed by the PGI, TESDA, Schools Division Office of Isabela, and TESDA Accredited Assessment Centers, enumerating their respective duties and responsibilities for the implementation of the Program;

WHEREAS, after a careful review of the Contract of Service this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Contract of Service on behalf of the Provincial Government of Isabela;

WHEREAS, Section 465 (b) (1) (vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Evyn Jay C. Diaz, duly approved and seconded in a session duly assembled, it was –
