ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-CAGAYAN VALLEY CENTER FOR HEALTH AND DEVELOPMENT AND PALANAN STATION HOSPITAL FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE TO INDIGENT AND FINANCIALLY INCAPACITATED PATIENTS (MAIFIP) PROGRAM

WHEREAS, acknowledging their mutual goals and shared commitment to public health, the PGI and the DOH-CVCHD have consistently demonstrated their readiness to collaborate on numerous programs and initiatives aimed at addressing the healthcare needs of their constituents;

WHEREAS, the DOH-CVCHD, recognizing the pressing need to address the healthcare challenges faced by indigent and financially incapacitated individuals, has allocated substantial funds under the General Appropriations Act for the implementation of the Medical Assistance to Indigent and Financially Incapacitated Patients Program, with the primary objective of extending essential assistance to those most in need within our communities;

WHEREAS, the allocated funds are intended to ensure the availability of medicines and healthcare services at the Palanan Station Hospital (PSH) a facility owned and operated by the PGI, to meet the needs of indigent and financially incapacitated patients;

WHEREAS, the execution of a Memorandum of Agreement between the DOH-CVCHD, the PGI, and the PSH is necessary to facilitate the Medical Assistance to Indigent and Financially Incapacitated Patients Program, formalizing the stipulated terms and conditions, and allowing the transfer of funds to the PGI for the provision of the essential medical assistance;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review of the said MOA, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

WHEREFORE, premises considered, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T.
