**WHEREAS**, Appropriation Ordinance No. 02 Series of 2024, an Ordinance authorizing Supplemental Budget No. 01 FY 2024 of the Local Government Unit of Quirino, Isabela amounting to **ONE HUNDRED FIFTEEN THOUSAND SEVENTY ONE PESOS & 58/100 (P115,071.58)** derived from the 20% share of LGUs in the proceeds collected from the FYs 2018, 2020, and 2021 of Fire Code Fees of the Municipality of Quirino, Isabela, was submitted to this office for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 02 S. 2024 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The utilization of the PPAs to be funded from the 20% share of LGUs in the proceeds collected from the FYs 2018 and 2020, 2018 and 2021 of Fire Code Fees amounting to One Hundred Fifteen Thousand Seventy One Pesos & 58/100 (P115,071.58) shall be subject to the provisions of DOF-DBM-DILG Joint Circular No. 2015-01 dated February 12, 2015 as revised by DBM-DILG-DOF Joint Circular No. 2023-01 dated April 17, 2023;
2. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the purchase and specifications of the motor vehicle shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and Budget Circular (BC) No. 2022-1 dated February 11, 2022, and BC No. 2022-1A dated March 1, 2023.

**RESOLVED FURTHER**, to require the Municipality of Quirino, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to inform the Municipality of Quirino Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable EDWARD D. JUAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable VICTOR EMMANUEL G. CALLANGAN**, Municipal Vice-Mayor.
