WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-014 (2023 Supplemental Budget No. 06) of the Municipality of Echague, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Four Million Eight Hundred Forty Five Thousand Pesos (P4,845,000.00) shall be in accordance with Administrative Order No. 12 dated December 7, 2023 and DBM Budget Circular No. 2023-2, dated December 13, 2023, on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for FY 2023. However, SRI shall be properly classified as Other Personnel Benefits with account code 5-01-04-990;
- 2. The grant of Gratuity Pay to Contract of Service and Job Order Workers of LGU- Echague, Isabela in the amount of Three Million Fifteen Thousand Pesos (P3,015,000.00) shall be in accordance with Administrative Order No. 13 dated December 7, 2023 and DBM Budget Circular No. 2023-3 dated December 13, 2023, on the Guidelines on the Grant of the Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in Government for FY 2023;
- 3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Echague, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable FRANCIS FAUSTINO A. DY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Echague, Isabela through the **Honorable ALLAN P. TUPONG**, Municipal Vice-Mayor.
