WHEREAS, Republic Act No. 9513, otherwise known as the Renewable Energy Act of 2008, establishes the State policy on the development and utilization of renewable energy (RE) resources as tools for the effective prevention or reduction of harmful emissions and the balancing of goals of economic growth and development with the protection of health and the environment;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to develop appropriate and self-reliant scientific and technological capabilities within their respective jurisdictions;

WHEREAS, the Provincial Government of Isabela recognizes RE as vital to addressing the challenges of climate change, energy security, and access to energy. Accordingly, it actively fosters a local environment that is conducive to investments in the RE sector and the development of RE technologies;

WHEREAS, submitted for the review of this August Body is the request of Linglingay Power Corporation (LPC), an institution duly registered with the Department of Energy (DOE) and duly authorized to conduct solar energy operations under DOE Solar Energy Operating Contract No. 2023-07-680, for the issuance of a Sangguniang Panlalawigan resolution supporting and interposing no objection to their development of an 82.082 megawatt solar power project in Barangay Linglingay, Gamu, Isabela;

WHEREAS, after careful review of LPC's corporate credentials and capabilities and with due regard to their compliance with the necessary permits and licenses, their solar energy operations contract with the DOE, and the benefits of establishing a 82.082 megawatt solar power project in the advancement of local goals on energy security, this August Body finds no cogent reason to deny the said request of LPC and hereby declares its support to their project in Barangay Linglingay, Gamu, Isabela;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION INTERPOSING NO OBJECTION TO AND EXPRESSING SUPPORT FOR THE DEVELOPMENT OF AN 82.082 MEGAWATT (AC) SOLAR POWER PROJECT IN BARANGAY LINGLINGAY, GAMU, ISABELA TO BE IMPLEMENTED BY THE LINGLINGAY POWER CORPORATION.
